

Terms and conditions of Memorandum of Understanding cum Inter-se Agreement.

Both the parties to this Memorandum of Understanding cum Interse agreement hereby mutually agree to the following terms and conditions;

1. Venue of Coaching

The venue of coaching will be GGDSD college Chandigarh.

2. Fee discount

Students of GGDSD college shall be provided with discount of 30 percent on the course fees. However, to encourage the students of GGDSD college who come from Economically Weaker Sections of the society, higher discount of 50 percent shall be given on the course fee.

Students who enroll for their competitive exam at the Vivek IAS Academy Centre at GGDSD college but who are not students of the GGDSD college shall be given the discount of 25 percent on the course fees.

3. Coaching timing

Final Year students (5 days a week, 5-8 pm)

First Year batch (Weekend batch, 10-2 pm)

The coaching timings are subject to change with a prior notice of three days after approval by the Principal, GGDSD College, sector-32 Chandigarh. The coaching timings of the Vivek IAS Career Academy centre at GGDSD college shall not have any clash or conflict with the normal study schedule of the GGDSD College, Sector-32, Chandigarh.

4. College infrastructure.

That the college shall provide fully equipped classrooms with fittings, fixtures, furniture etc. like AC, Fans, tubelights, study tables, chairs, desks, teaching boards etc. on monthly remuneration basis, the remuneration amount, in terms of money, so fixed shall be payable each and every month by Vivek IAS Career Academy to the GGDSD College, sector-32, Chandigarh.

5. College faculty.

In case of more than 20 students, college teaching faculty will also be roped in for imparting training in select courses as per the curriculum and approval of the Vivek IAS Career Academy and Management . The payment to the faculty shall be @ Rs. 1200 per hour (the rate at which Panjab University hires faculty at its civil services institute). However, it is pertinent to mention here that the prime aim and objective of this present draft document is to provide the best education to the students who will enroll themselves to prepare for competitive examinations. The interest/s of the students shall not be compromised at any cost.

6. Result oriented Coaching.

The competitive exam/s coaching to be imparted to the students must be result oriented shall be as per the pre-settled curriculum and Schedule of courses opted by the students, respectively. The performance report of students shall be prepared on quarterly basis and the final outcome / success ratio of students shall be monitored by the GGDSD College on quarterly basis by a committee constituted by Principal G.G.D.S.D College, Sector-32/C, Chandigarh.

7. Facilitation charges and Infrastructure Usage Charges.

The GGDSD college shall act as a facilitator between the students and the Vivek IAS Career Academy. The GGDSD College at Sector-32, Chandigarh shall provide its fully equipped classroom/s to Vivek IAS Career Academy to teach the specified courses related to preparation par excellence in competitive examinations. The Vivek IAS Career Academy shall pay Facilitation and Infrastructure Charges to the GGDSD College on monthly basis or as settled from time to time.

8. Indemnification Clause.

It is further agreed that the Vivek IAS Career Academy shall indemnify the GGDSD College authorities, sector-32, Chandigarh


